

ORDINANCE NUMBER 19-11010

AN ORDINANCE AMENDING SECTION 5-25 OF THE CITY CODE TO PERMIT CONSUMPTION OF ALCOHOLIC LIQUOR ON THE SALINE COUNTY LIVESTOCK AND EXPO CENTER GROUNDS AND BUILDINGS.

BE IT ORDAINED by the Governing Body of the City of Salina, Kansas:

Section 1. That Chapter 5, Article II, Section 5-25 of the Salina Code is hereby amended to read as follows:

Sec. 5-25. Consumption on specified property owned by the city.

Pursuant to K.S.A 41-719(e):

(1) It shall be lawful to drink or consume alcoholic liquor at the following locations and areas at times and places authorized by the rules and regulations adopted for such locations' operation:

- a. Within the fenced grounds of Dean Evans Stadium, located in the East Crawford Recreation Area;
- b. Within the confines of the Tony's Pizza Events Center, and on the grounds and parking lots under city ownership surrounding the Tony's Pizza Events Center, located in Kenwood Park;
- c. Within the confines of the Smoky Hill Museum, located at 211 West Iron Avenue;
- d. Within the confines of the portion of Memorial Hall leased to Community Access Television of Salina, located at 410 W. Ash;
- e. Within a sidewalk dining area, as defined within chapter 35, pursuant to a sidewalk café license agreement executed by the city commission; and
- f. On the following grounds and buildings of the Saline County Livestock and Expo Center, approximately located at 900 Greeley Avenue: Saline County Expo Stadium, the 4-H Building, Kenwood Hall, and Ag Hall.

(2) Only in association with a special event approved by the city manager, with or without conditions, based upon the information contained in a written application on a form provided by the city and consideration on the basis of criteria established by resolution of the governing body, it shall be lawful to drink or consume alcoholic liquor within the boundaries of the following locations:

- a. Jerry Ivey Park;
- b. Bill Burke Park;
- c. Oakdale Park;
- d. Those areas within the East Crawford Recreational Area other than within the fenced grounds of Dean Evans Stadium;
- e. The Municipal Golf Course; and
- f. Those areas within the Salina Business Improvement District Number 1 owned by the city and not requiring a special event temporary permit pursuant to section 5-24.

Section 2. Repealer. Existing section 5-25 is hereby repealed.

Section 3. Summary of Ordinance for Publication. This ordinance shall be published by the following summary:

On July 15, 2019, the City of Salina, Kansas, passed Ordinance No. 19-11010. The ordinance amends Chapter 5, Article II, Section 25 of the Salina Code by permitting the consumption of alcoholic liquor on the Saline County Livestock and Expo Center grounds and buildings.
